

Terms of trade for courses and events

Registration: Registration for courses and events at CareCam.dk takes place on a "First come, first served basis", as some events may have limited seats. Registration is made by contacting **Leila Eriksen** by mail. leilaeriksen@hotmail.com or by mobile phone (+45) 26 18 95 90. Registration is only valid once full payment for course participation has taken place. Rescheduling is possible by prior written agreement. Call us and hear more. It should be pointed out, that some courses may be reserved for target groups with a specific educational background/professional employment.

Payment: Payment is made by bank transfer to Nordea, Reg. no. 2417 - Account No. 6888-140-393. (International Reg. No 2275 IBAN DK83200006888140393 SWIFT NDEADKKK) stating the student's name, title of the course, as well as the month and year of the course. The payment includes, unless otherwise stated in the course description, course material, lunch, and refreshments. Books, posters, etc. may be possible to buy at a reduced special price, at some courses.

Cancellation: Registration is binding. If course participation is prevented, registration can be transferred to another person/colleague, who settles with each other according to the course levy paid. If course participation is prevented due to illness, 50% of the amount paid will be refunded up to 4 weeks before the course. CareCam.dk be informed in writing.

If a planned course/event is canceled - from CareCam.dk side - where it is not possible to offer a new teaching date/place of teaching/teacher - the amount of the course paid will be refunded. **CV-19:** The authorities' guidelines for Corona's development are, of course, followed. Current information is released immediately before the start of the course.

Responsibility: Neither CareCam.dk nor trainers can be held responsible for treatments, advice or any other form of information/advice that students communicate to third parties - before, during and or after the course.
